Grange Siding Job:

Rich Thomsen has two bids for blown-in Class One insulation which will help to get the building into shape. This is a first step.

There was communication received from the Charlestown Historical Society supporting cedar for the siding on the Grange building.

There was discussion regarding bringing the matter of the siding cost back to the taxpayers, and let them decide if going with cedar or vinyl is preferred.

Motion was made, seconded and approved to hire RJL Insulation, LLC to install blown in insulation into the Grange.
